

# Letter of authorization for Electronic Funds Transfer

Each party agrees to pay for its own costs of transmission or receipt of funds transfers hereunder. A payment hereunder shall be (i) considered timely if the payment is completed on the payment due date determined by the applicable agreement for goods and services and (ii) deemed completed when Seller's depository institution receives, or has control of, the payment. Seller will give thirty (30) days' advance notice in writing to Buyer of any changes in its depository institution or other payment instructions. Either party may terminate this agreement upon thirty (30) days' advance written notice to the other party. The laws of the State of Texas shall govern this Authorization.
